# CORNWALL LADIES COUNTY GOLF ASSOCIATION

## **CONDITIONS OF PLAY FOR COMPETITIONS**

#### **GENERAL CONDITIONS:**

- In all competitions where participation and/or the award of trophies is related to age, the definition of a competitor's age and eligibility is based on their age at midnight on 31st December in the year preceding the year of the competition. This conforms to the rules and practice adopted in many sports, including those applied by England Golf.
- In accordance with EG policies, the use of buggies in county competitions is permitted for both players and caddies who currently hold a club certificate denoting a long term impairment and have registered it with the CLCGA. Where a caddie holds such a certificate and the player does not, the player must walk in the normal way. Where a player holds such a certificate and the caddy does not, the caddy must walk in the normal way. It is the responsibility of the player to inform the competition organisers of their intention, so that formal authorisation can be given for buggy use in the stipulated competition. Such authorisation will not normally be withheld, but in circumstances where the availability of buggies is restricted or course conditions require limits to be set, the needs of players will take precedence over those of caddies.
- In all competitions including League matches, entrants must have at least 20 scores used for handicapping purposes in their WHS Record and 5 of which must be from Organised Competitions in the preceding year
- All players should dress appropriately for golf
- All Competitions should be played in accordance with Pace of Play Policy 5.6
- In the event of extreme weather for a competition with more than 18 holes being played and on advice re temporary course closure from the host club, the committee members present reserve the right to make the decision to cancel a second round of golf and award specific trophies in the most appropriate method decided on the day. eg. Best front and Best back 9 opposed to morning or afternoon rounds. If no advice is available from the host Club and only when the weather is extreme, the committee can make the same decision agreed by the majority of committee members present on the day

Every Competitor must be a member of the Cornwall Ladies' County Golf Association possessing at least one of the following qualifications as set out in Regulation 6(b) of the Women's County Golf Regulations in the England Golf Handbook:

- 1. Birth in the County
- 2. Residence in the County
- 3. Membership of a Club in the County

- 1. Handicap Index limit 20.4
- 2. Entries limited to 64 lowest handicaps
- 3. 36 holes stroke play, qualifying rounds

- 4. Entry fee (as decided annually at Delegates' Meeting in January): will not be refunded after closing date
- 5. Ties will be decided on the second 18, 9, 6, 3, 1 holes
- 6. 32 lowest gross scores will qualify, in two flights
- 7. The first 16 to compete for the **Championship** in match play: if all square after 18 holes, to play on until either player wins a hole. The Final will be played over 36 holes: if all square after 36 holes, to play on until either player wins a hole.
- 8. The second 16 to compete for the **Plate**, 18 holes each round. If all square after 18 holes, to play on until either player wins a hole.
- 9. The 8 losers in the first round of the Championship, to compete for the **Advanced Plate** in match play, 18 holes each round. If all square after 18 holes, to play on until either player wins a hole.
- 10. The Hon Secretary or Competition Secretary will arrange times of starting and playing partners
- 11. Competitors may not engage a professional or assistant professional as a caddie (Rule 10.3 see also Committee Procedure H1.2)
- 12. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 13. Distance Measuring Devices will be permitted
- 14. Closing date two weeks before the date of the competition

## <u>Western Morning News Challenge Cup</u> – Cornwall Ladies Club Championship

- 1. Open to all Clubs who qualify for the Championship
- 2. Handicap Index limit 20.4
- 3. Entries limited to 64 lowest handicaps
- 4. 36 holes, stroke play
- 5. Ties will be decided on the second 18, 9, 6, 3, 1 holes
- 6. Four lowest gross scores of an affiliated Club to be the winner
- 7. The Hon Secretary or Competition Secretary will arrange starting times and playing partners

#### JUNIOR COUNTY CHAMPIONSHIPS

Every Competitor must be under the age of 18 before 1<sup>st</sup> January in the year of the Championship and must be a member of the Cornwall Ladies' County Golf Association possessing at least **one** of the following qualifications as set out in Regulation 6(b) of the Women's County Golf Regulations in the England Golf Handbook:

- 1. Birth in the County
- 2. Residence
- 3. Membership of a Club in the County

Trophies: Scratch Cup; CLCGA Championship Plate (Scratch Runner up); Handicap Cup; Stableford Cup; Under 15 Salver (scratch)

#### **Conditions of Play**

- 1. Handicap Index limit 36.4 for Under15 and Junior Championship, 36.5 + for Futures Cup
- 2. 18 holes stroke play
- 3. Entry fee (as decided by the Junior Committee): will not be refunded after closing date
- 4. Ties will be decided on the last 9, 6, 3, 1 holes
- 5. Vouchers will be awarded
- 6. Competitors may not engage a caddie (Rules 10.3 see also Committee Procedure H-1.1)
- 7. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 8. Distance Measuring Devices will be permitted
- 9. Closing date two weeks before the date of the competition

- 5. For the Aggregate Cup, ties will be decided on the second 18, 9, 6, 3, 1 holes
- 6. Vouchers will be awarded for scratch and handicap scores
- 7. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.

- 5. For the Aggregate Cup, ties will be decided on the second 18, 9, 6, 3, 1 holes
- 6. Vouchers will be awarded
- 7. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 8. Competitors may not engage a professional or assistant professional as a caddie (Rule 10.3 see also Committee Procedure H-1.2

- 1. 36 holes Foursomes medal play
- 2. Handicap Index limit: 30.4
- 3. Not more than 3 pairs may enter from each Club.
- 4. Pairs to reverse order on tee for second round
- 5. Ties will be decided on the last 18, 9, 6, 3, 1 holes
- 6. Entry fee (see individual poster): will not be refunded after closing date
- 7. Vouchers will be awarded for the best nett scores for pairs and for teams
- 8. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 9. Caddies will not be permitted
- 10. Distance Measuring Devices will be permitted
- 11. Closing date two weeks before the date of the competition

### **INTER-CLUB HANDICAP SHIELD (DIVISION II)**

**Handicap Shield:** to be awarded to the Club team with the three best aggregate scores over 18 holes

**Andrews Cup:** to be awarded for the best individual scratch score

- 1. 18 holes medal play
- 2. Handicap Index 20.5 54.0
- 3. Clubs may enter up to **four** players, three best nett aggregate scores to count.
- 4. Ties will be decided on the last 9, 6, 3, 1 holes for the individual trophy
- 5. Ties will be decided on the last 9, 6, 3, 1 holes for three best nett aggregate scores for the Handicap Shield, if necessary, continuing to the 4<sup>th</sup>

- 6. Entry fee: (see individual poster) will not be refunded after closing date
- 7. Vouchers will be awarded for the best scratch and handicap individual scores and to members of winning teams
- 8. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 9. Competitors may not engage a professional or assistant professional as a caddie (Rule 10.3 see also Committee Procedure H-1.2
- 10. Distance Measuring Devices will be permitted
- 11. Closing date two weeks before the date of the competition

**Salvers:** to be awarded to the pair with the best stableford score

#### **Conditions of Play**

- 1. 18 holes four ball better ball stableford
- 2. Handicap Index up to 54.0
- 3. Ties will be decided on the last 9, 6, 3, 1 holes
- 4. 85% handicap allowance
- 5. Entry fee (see individual poster): will not be refunded after closing date
- 6. Salvers will be awarded to the winners and vouchers for other places
- 7. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 8. Competitors may not engage a professional or assistant professional as a caddie (Rule 10.3 see also Committee Procedure H-1.2
- 9. Distance Measuring Devices will be permitted
- 10. Closing Date two weeks before the date of the competition

#### JUBILEE COMPETITION

In aid of County Captain's chosen charity. All Clubs should donate a raffle prize to be brought to the September Delegates' Meeting. Non-members are welcome

#### **Conditions of Play**

- 1. Format to be decided by County Captain
- 2. Handicap Index up to 54.0
- 3. Ties will be decided on the last 9, 6, 3, 1 holes
- 4. Entry fee (see individual poster): will not be refunded after closing date
- 5. Vouchers will be awarded
- 6. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 7. Competitors may not engage a professional or assistant professional as a caddie (Rule 10.3 see also Committee Procedure H-1.2
- 8. Distance Measuring Devices will be permitted
- 9. Closing date two weeks before the date of the competition

#### **GAMMON TROPHY**

Inter-Club scratch match play competition, the draw to take place at the AGM.

You are reminded that, as all matches are held on a neutral ground, your Club should allow courtesy for these games to be played

- 1. All Clubs wishing to participate, must indicate in writing to the Hon Secretary before 31 October each year
- 2. Each team to consist of 7 players.
- 3. Matches to be played on neutral greens arranged by the Honorary Secretary or Competition Secretary, between May and October.
- 4. Matches to be played in handicap index order, highest first. Where there is more than one team member with the same handicap index, the Captain to choose the order in which they go out.
- 5. If play is **suspended** for any reason other than a dangerous situation e.g. flooding, players may discontinue play immediately or continue play of the hole provided they do so without delay (Rules 5.7a). If play is suspended because of lightning or other dangerous situation, play **must** be discontinued immediately. If a player fails to do so, she is disqualified. Play must be resumed from where it was discontinued (Rule 5.7c). In the event that play cannot be started, resumed or completed on the day of the match, the

- match will be deemed to be **abandoned** and will be replayed in its entirety on a future date arranged by the Honorary Secretary.
- 6. Match Sheets, which will be sent with start times, must be exchanged no later than ten minutes before the match start time when all team members must be present. These should be returned with the result to Hon Secretary or Competition Secretary (whichever is the organiser).
- 7. All matches should be played to a finish: a half at the 18th would only be acceptable if the overall result has been decided
- 8. Final to be played at Trevose unless that Club is one of the finalists
- 9. Memento to be given to winning team and to runner up
- 10. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 11. Competitors may not engage a professional or assistant professional as a caddie (Rules 10.3 see also Committee Procedure H-1.2)
- 12. Distance Measuring Devices will be permitted
- 13. Any Club that gives a walkover /concedes a match will be excluded from the Gammon Trophy the following year.

#### **VICE-PRESIDENTS' HANDICAP CUP**

Inter-Club individual handicap match play competition in two Divisions

Full Difference between the Playing handicaps of the players to be given.

- 1. Each Club will hold a knockout tournament, the winner's name and telephone number to be sent in writing to the Competition Secretary by **31st May**. Handicap Index limit genuine 30.4
- 2. Matches will be drawn by the Competition Secretary in two geographic divisions. You are reminded that as all matches are held on a neutral ground, your Club should allow courtesy for these games if the Club itself has entered a player. Failure to meet this requirement *may* result in the Club being unable to participate the following year.
- 3. All matches to be played on neutral greens to be arranged by the players concerned following an email from the Competition Secretary with course availability. If the players choose an alternate course they may be expected to pay a green fee and they should negotiate directly with their chosen Club. In the event of two players being members of the same Club, their match may be played on that green subject to the agreement of both players. Matches to be played between June and October.

- 4. The Competition Secretary will arrange a neutral green and date of the final between the Divisional finalists which will be referred by an officer of the Association.
- 5. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 6. Competitors may not engage a professional or assistant professional as a caddie (Rule 10.3 see also Committee Procedure H-1.2)
- 7. Distance Measuring Devices will be permitted

#### **LEAGUE SHIELD**

Inter-Club handicap match play competition in four divisions.

Teams should be selected using Handicap Index.

Full difference between the Playing handicaps of the players to be given.

Shields will be awarded to the winners of each Division at the AGM.

- 1. Handicap Index allowance 30.4 (players with higher Handicap Index must play off handicap index of 30.4).
- 2. Team to consist of 7 players.
- 3. A minimum of **2** players with Handicaps Index of 20.5 and above **must** be fielded by each team in each Division.
- 4. A minimum of **2** players with Handicaps Index of 20.4 or below **must** be fielded by each team in each division. If a Club is unable to field the requisite number of players with Handicap Index of 20.4 or below, players with higher Handicap Index may be substituted but they must play off a handicap index of 20.4.
- 5. If a team does not fulfil the handicap requirements (i) the match with the incorrect handicap shall be awarded to her opponent (ii) if both teams have offended the match shall be declared null and void and must be replayed.
- 6. Matches to be played home and away each season; each match to be played in order of Handicap Index.
- 7. Match sheets must be exchanged no later than 10 minutes before the match start time. There can be no substitutions once match sheets have been exchanged
- 8. After the match, the match sheet must be completed with the scores of each individual match and returned by the winning Captain to the Results Secretary.
- 9. Points awarded: 3 for away win: 2 for home win: 1½ for away draw: 1 for home draw

- 10. Ties on points will be decided on individual matches won
- 11. Top 2 teams in Divisions 2, 3 and 4 will be promoted and bottom 2 teams in Divisions 1, 2 and 3 relegated
- 12. All matches to be completed by 30<sup>th</sup> September. If a club finds on, or shortly before, the agreed date that they cannot field a full team, they must continue with a reduced team and concede the un-played matches. If fewer than four players are available, they may concede the entire match. In these circumstances **every effort should be made to rearrange** the fixture but if that proves impossible (for whatever reason) before 30<sup>th</sup> September, the concession stands and the defaulting Club is awarded no game points and penalised 3 league points. The Club that were available to play are awarded 4.5 game points and either 2 or 3 league points depending if the match was Home or Away.
- 13. All matches to be played to a finish unless the overall result has already been decided and the Captains agree exceptionally (for example in poor light or adverse weather) that unfinished matches should be curtailed. The results of such unfinished matches to be based on the situation at the point where they were curtailed.
- 14. If play is suspended for any reason other than a dangerous situation e.g. flooding, players may discontinue play immediately or continue play of the hole provided they do so without delay (Rules of Golf 5.7a). If play is suspended because of lightning or other dangerous situation, play must be discontinued immediately. If a player fails to do so, she is disqualified. Play must be resumed from where it was discontinued (Rule 5.7c).
- 15. In the event that the Captains agree that play cannot be commenced on the day of the match or, if suspended, resumed or completed on that day, the match will be deemed to be abandoned. Every effort should be made to rearrange the match by 30<sup>th</sup> September, and clubs should plan their match programme to allow some time for rearranged matches. If the Clubs are still unable to re-arrange the match then it will remain abandoned and no points will be awarded to either side.
- 16. No more than two temporary greens
- 17. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 18. Competitors may not engage a professional or assistant professional as a caddie (Rule 10.3 see also Committee Procedure H -1.2)
- 19. Distance Measuring Devices will be permitted

#### MIXED GREENSOMES

**Cups:** to be held by the winners for one year

#### **Conditions of Play**

1. 18 holes stableford Each player required to take a minimum of six drives each.

- 2. Handicap Index limit: gentlemen 20.4, ladies 30.4 (Members of CLCGA/CGU). Those players with Handicap Index above the limit must play off Handicap Index of 20.4/30.4
- 3. Numbers limited to 72 pairs
- 4. Entry Fee (see individual posters): will not be refunded after closing date
- 5. Ties will be decided on the last 9, 6, 3, 1 holes
- 6. Cups will be awarded for the best stableford score and vouchers/prizes will be awarded for other places
- 7. Players shall walk at all times unless prior permission for use of a buggy has been sought from the Committee which will only be granted on presentation of a certificate indicating a long term impairment (see Committee Procedure G-6) signed by the player's Club Secretary and Captain.
- 8. Competitors may not engage a professional or assistant professional as a caddie (Rule 10.3 see also Committee Procedure H-1.2)
- 9. Distance Measuring Devices will be permitted
- 10. Closing date two weeks before the date of the competition

#### **COUNTY PRIZE**

Each Club may nominate one competition each year for which the County will give a prize voucher of £15. The Handicap Index allowance to be 54.0. Competition to be completed in time for voucher to be spent by 30 September each year.
